



## **CONTRACT DISTILLING FEE SCHEDULE & SERVICE EXPLANATION**

**PRODUCTION OF CLIENT'S BRAND – WOODWORKS DISTILLING COMPANY:**

### **FACILITY & PRODUCTION FEES**

- **FACILITY USE (INCLUDING DISTILLER SUPERVISION): \$1,200/DAY**
  - **ADMINISTRATIVE & FACILITATION FEE: \$200/MONTH**  
INCLUDES UP TO 4 HOURS OF CLERICAL SUPPORT (BILLING, CORRESPONDENCE, SCHEDULING, COMPLIANCE TRACKING). ADDITIONAL HOURS BILLED AT \$40/HOUR.
  - **RECIPE CORRECTION & PROCESS DEVELOPMENT (BY HEAD DISTILLER): \$160/HOUR**  
BILLED IN 15-MINUTE INCREMENTS
  - **FORMULA DEVELOPMENT (FOR TTB SUBMISSION): \$200/MINUTE**

### **LOGISTICS & OPERATIONS**

- **DISTRIBUTION COORDINATION, RESEARCH, EXPORT CONSULTING, LOGISTICS: \$40/HOUR**
  - **SHIPPING PREPARATION, PACKAGING, HANDLING (WWDC STAFF): \$40/HOUR**
  - **HIRED LABOR (BOTTLING, LABELING, PACKING): \$20/HOUR PER WORKER**  
→ PAYABLE AT TIME OF USE
  - **PRODUCTION SUPPLIES (TAPE, SHRINK BANDS, TRAYS, CLOSURES, ETC.): PAYABLE AT TIME OF PURCHASE**

### **STORAGE**

- **ON-SITE STORAGE (WWDC PRODUCTION FLOOR):**
    - **\$50/PALLET/MONTH FOR UP TO 90 DAYS**
    - **\$100/PALLET/MONTH BEYOND 90 DAYS ("EXTENDED STORAGE")**  
STORAGE TERM BEGINS AT THE END OF EACH PRODUCTION RUN
  - **OFF-SITE STORAGE (WWDC REMOTE UNIT): \$100/MONTH**

## **SHIPPING & DISTRIBUTION**

- **PRODUCT DELIVERY:**
    - **IN-TOWN: \$2.00/CASE**
    - **OUT-OF-TOWN: \$2.00/CASE + \$0.72/MILE**
  - **DISTRIBUTION FEE:**  
**5% OF FOB (FREIGHT ON BOARD) PRICE, ASSESSED AT THE TIME OF SHIPMENT TO DISTRIBUTOR**

## **EXCISE TAX**

- **FEDERAL EXCISE TAX (FET): \$2.70 PER PROOF GALLON**  
**CALCULATED AT THE TIME OF BOTTLING**

## **PROJECT INITIATION & PAYMENT TERMS**

- **DEPOSIT: 50% OF ESTIMATED TOTAL FACILITY FEES DUE UPON EXECUTION OF MOU/PROJECT ACCEPTANCE**
  - **CLIENT RESPONSIBILITIES:**
    - **SUPPLY ALL RAW MATERIALS, SOURCED SPIRITS (IF APPLICABLE), PACKAGING AND BRANDING SUPPLIES**
    - **ARRANGE SHIPPING OF MATERIALS TO PRODUCTION SITE AT CLIENT'S EXPENSE**
    - **PROVIDE: BOTTLES, CLOSURES, LABELS, BOXES, SHIPPING LABELS, ETC.**
